### Payment of Membership Fee and Certificate of practice Fee for the year 2018-19

We take the opportunity to request you to renew your membership with the Institute by remitting the annual membership/certificate of practice fees, which become due for payment on 1<sup>st</sup> April, 2018 and need to be paid on or before 30<sup>th</sup> September, 2018.

Now, members have the option to pay advance Membership/COP fee in exact amount for 3 years (1+2 years) along with GST as a final payment and in case of any shortfall in case of revision of fee in future their Name/COP will not be removed from the Register of Members on account of such revision.
